## INFORMATION REGARDING THE SHARE REPURCHASE PROGRAM

*Bagnolo in Piano (RE)*, 12 December 2022 - **Emak S.p.A.** announces operations on treasury shares in the period from 5 December 2022 to 9 December 2022, with reference to the plan adopted with a resolution approved by the Shareholders' Meeting on 29 April 2022 (already disclosed to the market with a press release issued in date 29 April 2022) and started on 10 October 2022.
